General: The 2022 New Jersey High School Math Meltdown consists of a 1-week competition beginning April 4, 2022 and ending on April 8, 2022.

Definitions

“DimensionU Games” includes the Web and App Versions of Meltdown. Access to the Web Version of Meltdown is available for all Participants at www.DimensionU.com. The App Version of Meltdown is available through respective device app stores for iOS, Android and Amazon.

“Leaderboards” are electronic lists that show Participant rankings during the competition period of the New Jersey High School Math Meltdown.

“Game” is the individual Meltdown game found on the DimensionU website or in respective app stores entitled, **Meltdown for Math & Literacy**.

“Student Participant” is an individual who validly registers under these Official Terms and Conditions, meets the minimum age requirements (13+), is currently enrolled as a high school student in grades 9 through 12 in the state of New Jersey and who will play as a contestant in the New Jersey High School Math Meltdown. **All interested individuals MUST create a DimensionU account on DimensionU’s New Jersey High School Math Meltdown student signup web page in order to participate in the New Jersey High School Math Meltdown.**

“Teacher Participant” is an individual who validly registers under these Official Terms and Conditions, meets the requirement of being an individual who is currently employed as a teacher in the state of New Jersey and who creates a “SIGNUP” code to share with any New Jersey High School student meeting the requirements of a “Student Participant”. **All interested individuals MUST create a SIGNUP code on DimensionU’s New Jersey High School Math Meltdown Teacher signup web page in order to participate in the New Jersey High School Math Meltdown.**

Student Participant Registration for the New Jersey High School Math Meltdown

New Jersey High School Math Meltdown Registration will remain open through April 3, 2022 11:59:59 PM EST. The New Jersey High School Math Meltdown is comprised of a participant’s combined highest daily earned Meltdown scores from each day of the competition duration. A maximum of five (5) daily high scores (one from each day of the competition) for each participant will be aggregated to establish a total score for the competition. The top three (3) highest scoring participants at the end of the five (5) day competition period will be declared the winners, (subject to eligibility verification.)

A valid email address must be provided by the interested player at the time of Registration. A valid email is the primary means of communication used by DimensionU to notify Participants of prizes that they have earned. An invalid email is grounds for the Participant’s disqualification. DimensionU is not responsible for email communications that go to a participant’s SPAM folder. Failure of a winning participant to respond within 72 hours of being contacted by DimensionU, may result in forfeiture of their prize and subject to disqualification from the competition.

Limit one (1) valid registration per person. All registration materials become the sole and exclusive property of

DimensionU and receipt of such materials will not be acknowledged or returned. DimensionU is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, postage-due, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind whether mechanical, human or electronic. Only fully completed online, registrations are considered eligible but subject to verification of the participants' eligibility requirements. Proof of submission will not be deemed to be proof of receipt by DimensionU. By entering the New Jersey High School Math Meltdown, entrants fully and unconditionally agree to be bound by these Terms and Conditions and the decisions of the judges, which will be final and binding in all matters relating to the New Jersey High School Math Meltdown. All points shall be tabulated by DimensionU, Inc. All issues concerning conduct are monitored by DimensionU, Inc. management. Participants must meet the minimum age requirements (13+) and be currently enrolled as a high school student in grades 9 through 12 in the state of New Jersey.

Student Participant Eligibility

To compete in the New Jersey High School Math Meltdown, all Student Participants must complete the registration process and access the Web or App versions of DimensionU Game entitled, **MELTDOWN**. Minimum system and network specifications, along with additional support documentation, may be found at www.DimensionU.com/Support. Student Participants may contact DimensionU Support at support@dimensionu.com. These specifications are guidelines and do not ensure that all Participants' systems are able to successfully use the program. The DimensionU Support Center and other supporting tools and documents may or may not fully cover issues faced by users of the DimensionU Games. DimensionU is not responsible for Participant's computer, mobile device and network systems and their functionality.

Geographic Eligibility: All Student Participants must be enrolled as a high school student in the state of New Jersey. Void where prohibited, taxed or restricted by law.

Age and Grade Eligibility: All Student Participants must meet the minimum age requirements of thirteen and older (13+) and be enrolled as a high school student in grades 9 through 12.

Eligibility Restrictions: Employees, officers and directors of DimensionU, Inc. and its parent companies, subsidiaries, affiliates, partners, advertising and promotion agencies, manufacturers or distributors of New Jersey High School Math Meltdown materials and their immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of such employees/officers/directors are not eligible to participate in the New Jersey High School Math Meltdown.

Required Documentation: For valid entry into the New Jersey High School Math Meltdown and for qualification to receive a prize in any prize category, Participants must be able to provide acceptable documentation of the following: (1) Proof of age; (2) Proof of enrollment in a New Jersey High School and (3) Proof of enrollment in grades 9 through 12.

Earning New Jersey High School Math Meltdown Points

Game Play: Participants may earn points through game play with the DimensionU Games beginning on March 4, 2022 12:00:00AM EST. No points earned prior to March 4, 2022 12:00:00AM EST will be applied to the New Jersey High School Math Meltdown. Participants daily earned points is equivalent to their highest point earning game that day. All games played in the New Jersey High School Math Meltdown that adhere to the Terms and Conditions outlined in this document.

Rankings: New Jersey High School Math Meltdown rankings will be posted on electronic Leaderboards during the New Jersey High School Math Meltdown promotion period. The Leaderboards will list the highest game play leaders (as measured by daily points earned by playing the DimensionU Games).

Game and Content Level: Participants must play Meltdown offered in DimensionU Games to qualify to earn points. Participants must choose DimensionU Mathematics. DimensionU will assign curriculum daily to all participants

during the New Jersey High School Math Meltdown. DimensionU expressly reserves the right to add or change curriculum selections during the course of the New Jersey High School Math Meltdown. No exceptions to this rule will be permitted.

Format of Play: DimensionU expressly reserves the right to alter or amend the format of New Jersey High School Math Meltdown game play for any reason, including, but not limited to, changing the length and duration of each Mission, the Mission to be played, the length and duration of each Round, and any other mechanical or gaming component reasonably related to the games that are the subject of the New Jersey High School Math Meltdown. DimensionU further reserves the right, at its sole discretion, to cap points earned on each Mission played, should DimensionU believe that a Mission's score is not reflective of the Code of Conduct or rules of Fair Play.

Tiebreaker: In the event of a tie in any Round, the Participant who achieves the tying score first, according to the official New Jersey High School Math Meltdown time stamp (the electronic record of when the Participant completes the Mission in the DimensionU Games that results in the qualifying score), will prevail.

Student Participant Qualification for Prizes

Game Play Prizes for Overall Winner: Any Student Participant who finishes in the top 3 cumulative game play score for the competition period will win a prize

- 3rd Place: \$125 Visa Gift Card

Notification: DimensionU will notify a winning Student Participant within 2 business days of the competition ending. Verification of Student Participant eligibility will be required prior to prize distribution.

No more than three (3) attempts will be made to contact all winners by using the email contact information provided by the Student Participant during the New Jersey High School Math Meltdown registration process. It is the sole responsibility of Student Participant to notify DimensionU of any change in contact information during the course of the New Jersey High School Math Meltdown. If for any reason the Student Participant cannot be reached within 72 hours of initial notification, the Participant's prize shall be deemed forfeited. DimensionU also reserves the right to verify that each registered Student Participant is the player achieving qualifying scores.

Teacher Participant Eligibility

To participate as a Teacher in the New Jersey High School Math Meltdown, all Teacher Participants must create a SIGNUP code to share with potential student participants. Teachers may create a SIGNUP code at the DimensionU Teacher Signup webpage found at <https://signup.dimensionu.com/nj-mathmeltdown>.

Eligibility: All Teacher Participants must be employed as a teacher in the state of New Jersey. Void where prohibited, taxed or restricted by law.

Eligibility Restrictions: Employees, officers and directors of DimensionU, Inc. and its parent companies, subsidiaries, affiliates, partners, advertising and promotion agencies, manufacturers or distributors of New Jersey High School Math Meltdown materials and their immediate families (parents, children, siblings, spouse) or members of the same

household (whether related or not) of such employees/officers/directors are not eligible to participate in the New Jersey High School Math Meltdown.

Required Documentation: For valid entry as a teacher participant and to qualify to receive a prize, Teacher Participants may be required to provide documentation of the following: (1) Proof of employment as a teacher in the state of New Jersey.

Teacher Participant Qualification for Prizes

For any winning Student Participant, who had a referring Teacher Participant SIGNUP code at the time of Student Participant registration, a \$100 Visa Gift Card will be awarded to the referring educator. If no referring Teacher Participant code exists for the winning student, the prize is forfeited. Teacher Participants are eligible to WIN up to a maximum of three (3), \$100.00 Visa Gift Cards.

Notification: DimensionU will notify a winning Teacher Participation student within 2 business days of the competition ending. Employment at a New Jersey High School must be verified before prizes are distributed.

Verification of Teacher Participant eligibility will be required prior to prize distribution.

Additional Rules

Technical Malfunctions: DimensionU is not responsible for any technical or equipment malfunctions that may affect any Participant's game play during the New Jersey High School Math Meltdown. Honesty & Fair Play: Any Participant who engages in dishonest conduct or unfair play will be immediately disqualified from the New Jersey High School Math Meltdown and will no longer have access to any DimensionU website. If a Participant is disqualified, his/her prize shall be awarded to the next highest-ranking Participant. DimensionU will not permit the use of any in-game "exploits" or "glitching". Any use of unfair gaming practices including collusion, "griefing" (using tactics to irritate other players for personal gain) or otherwise violating the intended spirit of the games will be punishable by disqualification. In addition, dishonesty and unfair play under this paragraph includes, but is not limited to, cyberbullying (as it is defined by the applicable state and/or federal regulations), allowing or causing an individual other than the registered Participant to play using the registered Participant's account, using codes or passwords that have been "hacked" or obtained through other means not sanctioned by DimensionU, the use of external devices to alter or enhance performance within the games, and taunting or threatening other Participants in any manner.

DimensionU may, in its sole discretion, disqualify any Participant for dishonesty or unfair play at any time during the course of the New Jersey High School Math Meltdown. Finally, no Participant may use an explicit game name during the course of the New Jersey High School Math Meltdown. If DimensionU determines, in its sole discretion, that any Participant has used an explicit or offensive name to denote its game in any manner, the Participant and/or its educator will be notified. After notification, the Participant will have twenty-four (24) hours to modify the name. If,

in DimensionU's sole discretion, the modified name remains inappropriate, the Participant will be disqualified and will forever lose access to the DimensionU websites.

No Rematches: There will be absolutely no rematches, do-overs, replays, or second chances to compete at any point during the New Jersey High School Math Meltdown. All results and scores are final.

Disputes Between Players: DimensionU is not responsible for any disputes between Participants.
